## 2. ADOPTEE'S REPRESENTATIONS

The following representations and conditions apply to the placement of the aforementioned dog:

- a) As of the date of this agreement, the dog is in good health and free of communicable diseases.
- b) The Adopter has 72 hours to have dog examined by a veterinarian and to personally inspect the dog. Any claims must be made within this time period and will be verified by Adoptee's own veterinarian.
- c) Adopter may return dog to Adoptee for any reason at any time. If unable to reach us, contact the local breed rescue group.
- d) Adopter is completely satisfied with and waives any and all claims regarding the conformation, and outward appearance.

## 3. CONSIDERATION

## 4. STIPULATIONS

- a) Dog is "chipped" with an identification computer chip between the shoulder blades. HOME AGAIN/AVID number is   N/A   and Adoptee is listed as main owner. Adopter may list self as second contact.
- b) Any other arrangements may only be made with Adopter's written consent.
- c) If Adopter chooses to sell dog/bitch or otherwise place him/her elsewhere; **Adoptee will be provided first chance to re-acquire dog/bitch according to terms agreed to by Adopter and Adoptee at that time. Adopter agrees to cover all shipping costs if necessary.**



## 5. MAINTENANCE

- a) Adopter agrees to maintain this dog in good health, provide routine preventative health care including, but not limited to, inoculation, internal and external parasites, and - where indicated - heart worm preventative medication.
- b) Adopter further agrees to provide proper exercise as indicated in order to maintain this dog or bitch in proper weight and physical shape. A proper diet consists of top-quality dog food and supplements. Foods NOT to be fed include highly commercialized brands with artificial preservatives. Vitamin E is an acceptable preservative.
- c) Adopter agrees to start basic obedience training at an early opportunity. Adopter agrees to continue training through at least basic obedience.
- d) Adopter agrees to not to do SCHUTZHUND BITE/PROTECTION TRAINING of this dog or bitch. Adopter acknowledges that failure to meet the requirements of this section will invalidate Section 4.
- e) Adopter agrees that this dog or bitch is NOT to be LEFT IN A BACKYARD OR KENNEL ONLY. This dog or bitch is placed with the understanding that he/she is to go to carefully selected parties and that Adopter AVOWED the dog or bitch would become a member of the family. Adopter agrees to allow Adopter to visit the dog's or bitch's home on Adopter's request and in the presence of the Adopter.
- f) Adopter agrees Adoptee will **REPOSSESS DOG OR BITCH UPON EVIDENCE OF NEGLECT AND/OR ABUSE** at no expense to the Adoptee.
- g) And finally.....Adopter agrees that he/she understands this contract fully, and that this contract is under the jurisdiction of the State of Oregon, in the county of Multnomah. It is agreed the place of venue shall be in Multnomah County, Oregon.
